

# PCFA HISTORY and KEY ACHIEVEMENTS

# 2010

 Madam Li Xiaolin, President CPAFFC visited Tonga to meet the Princess Royal Her Royal Highness Princess Salote Mafile'o Pilolevu Tuita (HRH), they discussed the Friendship Forum and the idea of PCFA. Tonga China Friendship Association (TCFA) was registered in 2019, founding President was HRH and TCFA set up was promoted and facilitated by the then Ambassador of China to Tonga.

# 2012

• HRH attended the Friendship Forum in China and met the leaders of ACFS (Mr John Breheny) NZCFS (Mr Dave Bromwich), MCFS (Ms Pat Tauroa and Mr Danny Tauroa), VCFA (Mr Johnnie Lam) and commenced discussions about the establishment of the PCFA.

# 2014

 HRH tasked a TCFA Delegation (led by Tonga's Minister for Agriculture and Fisheries) to attend the Friendship Forum and confirm with other Pacific FAs the set-up of PCFA. Following the Friendship Forum, a meeting of Pacific FAs was convened and attended by Australia, New Zealand, Maori, Vanuatu, Tahiti, and Tonga (the 6 founding Members), CPAFFC attended as observer. The 6 FAs agreed to set up PCFA and Secretariat Support for PCFA's set up were Australia and Tonga.

#### 2015

• ACFS and TCFA met twice in Tonga (in 2015 and 2016) to confirm details and logistics for the inaugural PCFA Conference, including the registration of PCFA as a legal entity.

# 2016

- PCFA Inaugural Conference convened in Tonga, in addition to the 6 FAs, Fiji, and Solomon Islands also attended.
- CPAFFC President Mme Li and CPAFFC Senior Officials attended and CPAFFC and PCFA Leaders (HRH and Mme Li) signed an MOU for cooperation between CPAFFC and PCFA.
